







Details of the proposed lands

- There are 06 identified zones expected separate RFPs. Interested developers may purchase one or more REP documents from Procurement Division, 07th Floor, Urban Development Authority, "Sethsiripaya Stage I", Battaramulla from 9.00 hours to 15:00 hours on working days from 22nd May 2017 to 12th June 2017 upon a payment of non- refundable fee of Sri Lankan Rupees Twelve Thousand Five Hundred (LKR 12,500/-) inclusive of taxes for each zone.
- A Bid Bond 1% of the Base Value of the land to be paid in cash or in the form of bank guarantee encashable on demand issued in favour of Chairman, Urban Development Authority by a bank operating in Sri Lanka registered in Central Bank should be submitted along with the RFP. The Bid Bond shall be valid for 210 days from the date on which the bids are to be closed.

RFP document addressed to the Chairman, Revenue Tender Board (Major) UDA, shall be dispatched via registered post or place in the Tender Box, which will be kept at the Procurement Division, Urban Development Authority, 7th Floor, Sethsiripaya Stage I, Battaramulla on or before 04th July 2017.
