SPECIFICATION FOR RED LENTIL

REQUIREMENTS;

- Red Lentils shall be the husked and split seeds of lens culinaris medic. They shall be hard and clean, reddish in color having a smooth surface.
- Red Lentils shall be free from objectionable foreign odor, Varietal admixture, pet infestation and mould growth.
- Red Lentils shall be free from added coloring matter.
- Red Lentils shall not contain pesticide residues.
- Red Lentils shall also conform to the requirements given in table
